Beautiful Trophies awarded for 1st, 2nd, and 3rd place individual events; Medallions for 4th place. Medals for all Youth Forms competitors; Medallions for all Team Events.

World-Class Panam Open Medallions for 1st – 4th place Adult Black Belt Koshiki Winners

Grand Champion Trophies will be awarded for Black Belt Forms, Adult Kyu Forms, Youth Beginning Forms, Youth Intermediate Forms, Youth Advanced Forms, Black Belt Weapons, Adult Kyu Weapons, Youth Weapons, Black Belt Men Sparring, & Black Belt Women Sparring. *(10 USAMA World Champion Titles)*

Finals Competitors will consist of:

All 1st Place Forms Winners; All 1st Place Weapons Winners; 1st Place Adult Black Belt Men Sparring & 1st Place Adult Black Belt Women Sparring Winners will be competing for *10 Beautiful Grand Champion Awards*! Top 2 Adult Black Belt Sparring Teams will Fight for 1st and 2nd Places at Finals. Top Panam Koshiki Teams will "Fight off" at Finals.

Competitor Equipment/Attire:

Mandatory Forms & Weapons Attire: Traditional uniform respective to his/her style.

<u>Mandatory Sparring Equipment & Attire: Foam</u> Handgear, Headgear, & Footgear (**No** Ringstar Shoes), Mouthpiece, Groin Protection (All males). <u>Uniforms must cover elbows.</u> (Check with Chief Referee for Gear Approval)

<u>Mandatory Koshiki Gear:</u> Mouthpiece & Groin protection (All males). Headgear, Chest Protector, & Hand Covers will be provided at ring. Hand Covers will also be available for purchase. <u>Adult Black Belts must wear White Uniform</u>; All other koshiki competitors are encouraged to wear white uniforms.

<u>Prohibited items in Sparring & Koshiki:</u> For the safety of our competitors, <u>No</u> metal or hard plastic joint braces, plaster or fiberglass casts are allowed. <u>No regular eyeglasses allowed</u>, however, safety sport goggles are allowed. Medical devices must be approved by Medical Personnel and Chief Referee.

<u>Disqualification:</u> A competitor may be disqualified for excessive contact, illegal techniques, or unsportsmanlike conduct and <u>not</u> entitled to a refund nor allowed to fight in any further events that day. Coaches and Spectators' unsportsmanlike conduct may also be cause for a competitor's disqualification.

<u>Judges Attire</u> for <u>Tournament</u>: Traditional martial arts uniform, dress pants or skirt with white dress shirt or USAMA polo shirt with dress pants, or suit during the competition. We appreciate your professionalism.

Judges Meetings:

We will be conducting a Judges' Meetings on Saturday at 8:30 am & Sunday morning at 9:00am in Exhibit Hall A-B just before we begin the tournament. All aspects of the rules will be addressed for each day's Events.

Mr. Michel Laurin is the USAMA Koshiki Chief Referee and Executive Board Member for Koshiki PanAm. He will be conducting a Koshiki Referee Seminar on Friday, August 2nd, from 11:00 am to 2:00 pm in Meeting Room MR 3 on the Lower Concourse. 
